All Conference Delegates should plan on attending the Annual Meeting. If you have any questions regarding the meeting schedule, please contact either of the undersigned.

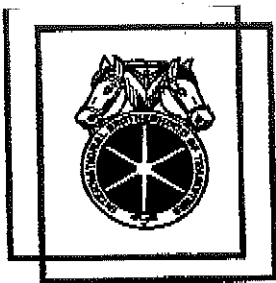
