Based on the extended poor economic conditions, it is imperative that operations within YRC terminals continue to be consolidated as quickly as possible thus eliminating inefficiency within the network.

With the proposed realignments in the network, the following terminals will have some or all utility positions eliminated to further strengthen the overall network and reduce operating costs.

This change of operations is filed in accordance with Article 3 section 7 of the NMFA. All transferred employees will be dovetailed in accordance with their present bidding seniority. Any disputes regarding seniority will be handled by the change of operations committee.

The Company agrees that nothing in this proposed Change of Operations is intended to violate and/or alter the provisions of the NMFA or the applicable supplemental agreements. The Company will operate in accordance with DOT rules and regulations and current hours of service provisions.

Any relocation of employees will be handled in accordance with the contract.
